**OFFICE FEE:**

\$35. (\$10 refundable if entry is initially received correct, complete and in hand by closing date. Office fee charged for changes after closing date. (No charge for changes due to conflicts). Include legible email address.

**REFUNDS:**

Before closing date, fees will be refunded less \$35 office fee. No refunds after closing date or after start of competition. No refund for cancellation due severe weather or other emergency conditions. Returned check policy: Incur a \$35 charge and void entry until money order, certified check, or cash is received. Post entries will be placed on a wait list to fill scratches or No Shows. **Guest horses** (non-competing) welcome, submit signed entry, Coggins, \$25 admin fee, \$35.00 office fee, and either stabling or day parking fees.

**ENTRIES:**

Please fill out entry form completely and correctly. Enclose current Coggins & other required documents. Draw checks to Delta Dressage Mail to: Secretary. (Waive any Signatures Required for express mailing ) Specify test in TOC. All entries must be received by closing date. Acknowledgements will be emailed. Send SASE if no internet access.

**TIMES:**

Official times available noon Friday before show at the secretary's office. Monday before the show unofficial times will be posted on show website: [www.deltadressage.com](http://www.deltadressage.com) . Include SASE for mailing times if no web access.

**STABLING:** Permanent 10 X 10 stalls, with doors. Shed row style with overhang, on site. Barns have wash racks. Two bales shavings with each regular stall (not tack) Preorder extra shavings (\$7.50) to have them pre-delivered for Friday. **Groups specify ONE NAME to coordinate stalls.**

**ARENAS:** One indoor and One outdoor 20m X 60m sand/clay competition arenas. One large covered sand/clay warm up arena. Competition and warm up footing are the same. Arenas open for schooling Noon to 4:00 pm Friday. Separate lunging area

**HOSPITALITY:**

Food is available on the grounds during the competition. Many restaurants and fast food within two miles.

**ACCOMMODATIONS:**

**DIRECTIONS:**

**From Nashville:** Take I-40 west to exit 16A. Merge on to TN177/Germantown pkwy toward Germantown. Go 5 miles. Entrance is on right .4 miles south of Walnut Grove overpass. **From Arkansas or Mississippi** take I-240 exit #13 on to Walnut Grove Road East. Go 3.8 miles and merge right (south) on to Germantown Rd. Entrance is south .4 miles on the right. Address: 105 S. Germantown Rd, Cordova, TN 38018

**OTHER:** Management requires all riders to wear appropriate protective head gear whenever mounted. Entries are on a first come-first served basis.

**All dogs must be leashed at all times.**

**Important - Please Read Carefully**

***This section will save you Sooo much time \$\$ and aggravation!!!***

**Competitors are responsible for reproducing their own entry forms.** They are further responsible for supplying management with correct association numbers (USEF, USDF) for horse, owner, rider and trainer before the start of the competition. **Failure to do so may result in scores not being counted towards year-end awards.** **USEF / USDF membership and horse registration cards can be printed for riders and owners at all on one sheet at:**

Tennessee and Mississippi and Georgia require a negative Coggins dated within 12 months of the show. *Tennessee and Georgia law requires competitors to bring original Coggins to the show grounds and must present it when picking up their competition packets.* (Copies of valid Coggins should also accompany entry.)

A **Junior** is eligible to compete until the end of the calendar year in which they reach age 18. A **Young Rider** is eligible from the beginning of the calendar year they reach 16 until the end of the calendar year in which they reach age 21. However, FEI Junior Tests are open only to Juniors from the beginning of the calendar year in which they reach the age of 14 until the end of the calendar year in which they reach the age of 18. Dressage riders who are between the ages of 18-21 cannot compete in Adult Amateur classes in Dressage competitions, even if they are in possession of a USEF Adult Amateur membership card.

For USDF non-member (NM) owner/lessee and USDF non-member rider there will be a USDF non-member fee of \$20/competition that must be collected by the show secretary and submitted along with the USDF Report of Fees document. In addition, a \$5 affidavit fee must be collected if the person cannot provide a copy of their USDF NM card. (For persons applying for the first time for a non-member number the \$5. affidavit fee is not required.) Owners/lessees or riders exempt from the non-member number requirements are also exempt from paying the USDF non-member fee.

**Exceptions:** Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number requirements and fees. These classes include Individual Breed Classes (IBC) at DSHB competitions; breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), USDF Introductory Level, Pas de Deux, Opportunity Classes.

**Amateur (A)** classes are open to riders, from the beginning of the calendar year they reach age 22, who hold an USEF amateur card.

All entries must be signed on all applicable lines. The adult who assumes responsibility for the horse at the show signs as "Trainer." Juniors MUST have their parent or legal guardian sign for them, as well as signing their own signature. Juniors and Young Riders also need to fill in their birth date to qualify for (Y) classes.

No horse may compete in more than two successive levels at any one recognized show (i.e. Training and First are permissible, Training and Second are not). Only one rider per horse in any one class. Lateness will result in elimination.

**USEF requires all adult competitors to submit proof of USEF membership** or pay the \$30 non-member fee. Junior non-members pay a \$30 non-member fee. All USEF members (including riders, handlers, trainers, owners, agents, coaches or lessees) are required to present either their actual membership card or a facsimile to show the show secretary prior to competing. Each competitor is responsible for supplying show management with correct association numbers (USEF, USDF) for horse, owner, rider, coach (if applicable) and trainer, before the day of the competition. The scores of the competitors who fail to supply correct numbers may not be counted toward national/local awards. **We strongly advise you to renew your USEF membership early and enclose a copy of your USEF membership card along with your entry to avoid possible penalties and confusion.**

**Only a complete entry will garner the office fee refund.**

#### **USEF MEMBERSHIP STATEMENT**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

#### **FEDERATION ENTRY AGREEMENT**

By entering a Federation-recognized Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulteur or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the competition may use or assign photographs, videos, audios, cable-casts, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR1502.5.

United States Equestrian Federation, Inc. Entry Agreement

**I have read the United States Equestrian Federation, Inc. (the "Federation") Entry Agreement (GR1502.4) as printed in the Prize List for this Competition and agree to all of its provisions. I understand and agree that by entering this Competition, I am subject to Federation Rules, the Prize List, and local rules of the competition. I agree to waive the right to the use of my photos at the competition, and agree that any actions against the Federation must be brought in New York State.**

**Neither the Organizing Committee, show volunteers and staff, the facility or its owners, any host GMO, USEF or USDF or their members will be responsible for any damage, injury, or loss to persons, horses or property of exhibitors or spectators. All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.**

**Qualifying Classes** GAIG/USDF qualifying classes require both the rider and the horse be registered with the USEF and the USDF at the time the qualifying scores are earned. **COPIES OF USEF and USDF MEMBERSHIP CARDS AND USEF & USDF HORSE RECORDING CERTIFICATES MUST ACCOMPANY ENTRIES.** The fee for GAIG/USDF qualifying is \$10 extra per class. Please refer to the back of this book for more complete information on the GAIG/USDF Championships.

Freestyle entrants must submit copy of 60% +ride in the highest test of the level or tes of any higher level. Submit music to announcer at least 4 hours before the ride and arrange a sound check

*Either the USDF HID# or a USDF Lifetime Horse Registration is required for all horses competing in the USEF/USDF recognized Dressage Competition or open (dressage or DSHB) class at a USEF/USDF recognized Regular or Local Competition. Horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (i.e. all Arabian or all Morgan classes) or in USDF Introductory Level tests, Pas de Deux, IPEC or quadrille classes are exempt from this requirement. Also exempt are riders in lead line, exhibitions, games and races, classes for 4-H members, and walk-trot and academy classes. Any horse participating in a GAIG/USDF Breeders' Championship Series Final, GAIG/USDF Regional Championship qualifying or championship class, or the USDF Horse of the Year award program must be lifetime registered with the USDF. All riders, handlers and owners must have USDF membership or nonmember ID number. All horses must be USEF Recorded, USDF Lifetime Registered or have Horse Identification Numbers for both USEF and USDF (except IBC).*

*Riders USDF membership may be either Participating or Group. Owner's USDF membership may be Participating, Group or Business; if Rider/Owner's USDF # is a Non-Member ID# then the USDF non-member fee must be paid. If the Non-Member ID card is not available then an Affidavit fee must be paid.*

Pursuant to USEF rule 1211.5 each barn has one sharps container per 50 horses. Competition management may fine any individuals including trainers, owners, exhibitors, or their agent up to \$100 for improper disposal of needles or other sharps disposable instruments.

**All Junior riders (18 and under) who qualify for the GAIG/USDF Regional Championships at any level are automatically qualified to compete in the 2010 U.S. Equestrian Dressage Seat Medal Semi-Finals** to be held at each of the nine GAIG/USDF Regional Championships in 2009. One semi-final class will be offered for Juniors age 13 and under, and a second semi-final class will be offered for Juniors age 14-18. Contact the U.S. Equestrian Dressage Dept. for more information @ (859) 258-2472.

**USDF / Dover Adult Amateur Medal Award:** Awarded to the Adult Amateur with the highest score, 60% or better, in a Second Level Test 3 USDF/Dover Adult Amateur Medal Class. To be eligible, a rider must be a USEF adult amateur and a USDF Group Member, Participating Member or Intercollegiate/Interscholastic Member. No additional memberships are required. Each winner will receive a custom pewter medal.

Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/ or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of the competition.

*Minors who do not have a valid drivers license which allows them to operate a motor vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the show grounds of recognized competitions.*

*Children who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid drivers license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s), and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardians .and/ or trainer(s) from the show grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Rule VI. Wheelchair is exempt from the definition of a motorized vehicle for purposes of this rule.*

Under NC, SC, GA, and TN law, an equine activity sponsor, or equine professional is not liable for an injury to or the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities. (See N.C. Gen. Stat § 99E-1-3, S.C. Code Ann. § 47-9-710-730, TN Code Ann. § 44-20-101-105 and GA Chapter 12 title 4 of the Official Code of Georgia annotated.

#### **All entries must have 3 signatures - Rider, Owner and Trainer.**

Legal Guardian must sign for riders under 18 yrs. Trainer blank must be signed by person over 18 who assumes responsibility for horse. (Parents who sign as trainer are exempt from membership requirements). See **www.usdf.org** and **www.equestrian.org** and/or USEF Rule Book for further details on entry requirements. Questions?   1. Use the back side of your Coggins copies to copy all your Current USEF, USDF, GMO membership cards and Horse Registrations (you can reduce the size) to send in with your entries. All you information will be at hand when you want to get that entry done!

**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership, Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF NM fee. (Note: USDF business members can own horses but cannot compete as riders with their USDF Business Membership (BM).)

Horses competing at USEF-licensed/USDF-recognized shows must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, Pas de Deux, Quadrille, or FEI ParaEquestrian classes, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot and academy classes. For foreign-owned horses competing in a CDI, USDF accepts copies of the horse identification pages from an FEI passport in lieu of a USDF HID or Lifetime Horse Registration (LHR) number.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

#### **Memberships Defined**

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$62), 5-years (\$250), or life (\$1,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$35). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan<sup>®</sup>/USDF Year-End Awards, Great American Insurance Group/USDF Breeders' Championship Series Finals, and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$175) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$20 and a USDF NM form per competition that must be collected by the show secretary and submitted to USDF along with the USDF Report of Fees document and the \$5 affidavit fee if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF member there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF Web site.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$20). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan<sup>®</sup>/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes or Great American Insurance Group/USDF Breeders' Championship Series Finals. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$65. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$85) is eligible for Adequan<sup>®</sup>/USDF Year-End Awards, and eligible to compete at Great American Insurance Group/USDF Breeders' Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

#### **How to Join USDF**

Applications for USDF Participating Membership (PM), Business Membership (BM), Non-Member (NM) identification number, Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date received by the competition secretary, provided the application is signed and dated by the competition secretary on that same day.

## 2010 USDF/Dover Saddlery Adult Amateur Medal Program

The USDF/Dover Saddlery Adult Amateur Medal Program is designed to specifically recognize and encourage adult amateurs riding at Second Level.

### Awards

#### 1. USDF/Dover Saddlery Medal Recipient

The eligible rider with the highest score of 60 percent or better in the designated Second Level Test Three class or applicable test of choice USDF/Dover Saddlery Adult Amateur Medal class at a participating competition will receive a handcrafted USDF/Dover Saddlery pewter medal and neck ribbon. Winners will receive a \$20 Dover Saddlery gift certificate for the first three USDF/Dover Saddlery Medals they win during the competition season.

#### 2. USDF/Dover Saddlery National Merit Award

A USDF/Dover Saddlery National Merit Award will be awarded to riders winning three USDF/Dover Saddlery Medals in the same competition year.

#### 3. Year-End Awards

The USDF/Dover Saddlery Medal National Champion and Reserve Champion are determined from the average of the top three winning ride scores during the competition year. The champion receives a \$1000 Dover Saddlery gift certificate and the reserve champion receives a \$500 Dover Saddlery gift certificate.

### Rider Eligibility

To be eligible, a rider must meet the following criteria:

1. Rider must be a current USDF participating or group member at the time of the competition.
2. Rider must be an adult amateur in accordance with Article GR1306 of the USEF rules and be designated with USEF as an adult amateur as of the competition date.

# Important Information for New USEF Dressage “Opportunity” Classes

**1. *When do the new rules take effect for dressage “opportunity” classes?***

December 1, 2009, which is the official start of the 2010 USEF competition year. This date coincides with the effective date of the new “Levels” required for Dressage Competitions.

**2. *What types of competitions may offer these classes?***

Licensed Dressage Competitions and Regular/Local Competitions which are licensed to include an Open Dressage Division (open to all breeds) may offer a limited number of dressage “opportunity” classes, as described in Rule GR821. (See #4 below for the list of classes and tests that may be offered.)

**3. *So may a breed-restricted competition offer these classes?***

No, unless the competition is licensed to hold an open dressage division which is open to all breeds. This is because breed-restricted competitions are not required to meet any of the new dressage competition levels standards.

**4. *How do I know what type and how many dressage “opportunity” classes I can offer at my competition?***

The type and number of classes which may be offered is dependent upon the “level” of your competition. Only Level 1, 2, or 3 competitions may offer these classes (please refer to the published Dressage Levels chart on the USEF website and GR821).

- **A Level 1 Competition may offer two (2) tests, per level, per day, at Second Level and below.** For instance, in a single day, a show could offer Training Level Test 1, Training Level Test 2, First Level Test 1, First Level Test 2, Second Level Test 1, and Second Level Test 2 as “opportunity” classes.
- **A Level 2 Competition may offer two (2) tests, per level, per day, at FIRST Level and below.** For instance, in a single day, this show could offer Training Level Test 1, Training Level Test 2, First Level Test 1, and First Level Test 2 as “opportunity” classes.
- **A Level 3 Competition may offer two (2) tests per day at Training Level ONLY.** For instance, in a single day, this show could offer Training Level Test 1 and Training Level Test 2 as “opportunity” classes.
- **A Level 4 or Level 5 Competition may not offer “opportunity” classes.**

**5. *How do I list these classes in my prize list?***

Per Rule GR821.8, the list of “opportunity” classes offered must include “Opportunity” in the class name.

**6. *Can I offer Eventing Dressage Tests or other types of tests as “opportunity” classes?***

No, as indicated above and in the Dressage Levels Chart, only specific USEF Second Level, First Level, and Training Level Tests may be offered as “opportunity” classes.

**7. *Can I have an Opportunity Test of Choice class?***

No. Please see #5 & #6 above. Only specific tests may be offered.

**8. *What about Freestyles?***

Per Rule GR821.2e(3), Freestyles may not be offered as “opportunity” classes.

**9. Can I offer one of these “opportunity” classes as restricted to Adult Amateurs?**

Yes, but per Rule GR821.5, if an “opportunity” class is restricted to Amateurs, then the rider must have an amateur status on file with USEF or pay the \$30 non-member amateur card fee.

**10. Who can judge these classes?**

USEF Rule GR821 states that any judge officiating at the competition may judge the “opportunity” classes. Since these classes may only be offered at Licensed Dressage Competitions and Regular/Local Competitions with Open Dressage Divisions, the judges would be USEF-Licensed “r”, “R”, “S” or FEI Dressage Judges.

**11. What rules apply for these classes?**

Since these classes may only be offered at Licensed Dressage Competitions and Regular/Local Competitions with Open Dressage Divisions, all USEF Dressage Division (DR) rules apply, including dress and saddlery requirements, in addition to all applicable General Rules, such as Drugs & Medications (see #14, below).

**12. What memberships are required for these classes?**

Per Rule GR821.2e(5), horses and riders competing in “opportunity” classes are exempt from USEF and USDF membership requirements, and do not have to pay non-member or HID fees. *(In addition, USEF is working on a rule clarification to also specify that owners, trainers, and coaches are exempt from membership requirements.)*

**13. Can a horse and rider cross-enter into other dressage classes?**

Yes. Your prize list must state if “opportunity” riders/horses will be allowed to cross-enter into other recognized classes at your show. Please note, however, if a horse or rider enters other non-opportunity classes at your competition in which membership by participants is required, all USEF and USDF membership requirements apply for horse, rider, owner, trainer, etc. (See GR901.9 for more information.)

**14. What about the USEF Drugs & Medications fee?**

Per Rule GR821.3 & .4, horses entered only in “opportunity” classes are exempt from the Federation fee, including the Drugs & Medications fee. However, horses entered in these classes are still subject to and must comply with all D&M rules and are subject to testing at your competition.

**15. Do I submit results for these classes to USEF?**

As per Rule GR821.1, competitions must submit full results of all “opportunity” classes as required in Rule GR1214:

- “Opportunity” must be listed in the class name in the results.
- Full results are required – names of horses, riders, owners, and trainers are to be listed including addresses, placings and scores, eliminations, etc.
- If they have them, horses and members with USEF numbers should be listed in the results. If membership or HID information is missing, please leave the USEF number field blank.
- Section codes for submission of e-Results are as follows: Open Opportunity – 5702; Amateur Opportunity – 5703.

**16. What about the USEF Post-Competition Report?**

Since “opportunity” classes are exempt from membership, non-member fees, Drugs & Med Fee and the Federation Fee, these classes are not reported on the Post Competition Report.

**17. Can “opportunity” class results count towards USEF or USDF awards?**

No. Scores earned in dressage “opportunity” classes may not be used towards USEF or USDF awards or programs.
