AWARDS: Trophy (or certificate of charitable donation to horse rescue charity) and five ribbons. High Score will be awarded for overall high score for AA, O and JR/YR (Intro - FEI) To qualify for Divisional Award consideration, at least 3 classes must be entered in Intro - Second or 2 classes in Third Level and above, in the same division by one horse/rider combination. Scores will be averaged and the highest average score will receive the award. **Breed awards:** KWPN-NA Award, North American Danish Warmblood Assoc, Oldenburg Horse Breeders, American Warmblood Registry, American Hanoverian Society, American Holsteiner Horse Assoc, American Trakehner Assoc., Friesian Breed Award and Arab Breed Award. (Present registration information with entry.)

OFFICE FEE: \$35. (\$10 refundable if entry is initially received correct, complete and in hand by closing date.) Office fee charged for changes after closing date. (No charge for changes due to conflicts). Include LEGIBLE email address. **REFUNDS:** Before closing date, fees will be refunded less \$35 office fee. **No refunds after closing date or after start of competition.** This includes classes cancelled due to severe weather or other emergency conditions.. **Returned check policy:** Void entry and incur a \$35 charge, entry wait listed until money order, certified check, or cash is received.

ENTRIES: Please fill out entry form completely and correctly. Draw checks to Delta Dressage. Mail to Secretary (Waive any Signature Requirements for mailing). **EACH ENTRY MUST HAVE COPIES OF REQUIRED DOCUMENTATION ATTACHED. All definitions and rules relating to this show are covered under the General Guidelines earlier in this document. Every class offered herein which is covered by the rules and specifications of the current USEF rule book will be conducted and judged in accordance therewith. Late entries will be put on a wait list and may be accepted to fill scratches and no shows. Acknowledgements will be emailed.

TIMES: Official times available Friday at the Secretary's stand. Riders assume responsibility for verifying correct entry information. Management not responsible for errors. Times posted Monday PM before show.

STABLING: 12 Permanent indoor 10 x 10 stalls with doors. 16 Temporary 10 x 10 stalls with doors under cover. One bag initial bedding.

ARENAS: One indoor sand/felt composition arena. Indoor warm up same footing. Lunging on grounds.

HOSPITALITY: Delicious Food & Beverages on the grounds during the show.

ACCOMODATIONS: Limited number of rooms available on site. Call 901-277-8108 for rates & availability. Super Eight 662-429-5335, Days Inn 662-429-0000, Scottish Inn 662-449-2900

DIRECTIONS: From Memphis, TN take I-55 south to Nesbit Exit 284. Go right off ramp .2 mile to 4-way stop at Hwy 51. Turn south/left onto hwy 51. go 4.5 miles (through 4-way stop at Robinson St, Through lights at HWY 304 and Losher St.) and turn right on Oak Grove Road just past Chevron Station. Go .3 miles to 4 -way Stop at Robertson Gin Road. Turn south/left onto Robertson Gin Road. Go 3.7 miles to Clifton Farms on Right.

From Jackson, MS on I-55 North take Coldwater/Hwy 306, Exit #271. Turn west/left onto Hwy 306. Turn North/Right on to Hwy 51. Go 3 miles. Turn west/left onto Wheeler Road at Citgo Station. Go 1.6 miles and turn north/right onto Robertson Gin Road. Go 1.6 miles to Clifton Farms on your left.

OTHER: Facility requires all riders under 21 years old to wear ASTM approved helmets when mounted. All riders are required to wear appropriate protective head gear when mounted. Entries and stable assignment are on a first come-first served basis. **No Dogs in Arenas. All dogs must be leashed at all times.**

Important - Please Read Carefully

This section will save you Sooo much time \$\$ and aggravation!!!

Competitors are responsible for reproducing their own entry forms. They are further responsible for supplying management with correct association numbers (USEF, USDF) for horse, owner, rider and trainer before the start of the competition. **Failure to do so may result in scores not being counted towards year-end awards.** USEF / USDF membership and horse registration cards can be printed for riders and owners at all on one sheet at: <http://www.eqverification.org/>

Tennessee and Mississippi and Georgia require a negative Coggins dated within 12 months of the show. *Tennessee and Georgia law requires competitors to bring original Coggins to the show grounds and must present it when picking up their competition packets.* (Copies of valid Coggins should also accompany entry.)

A **Junior** is eligible to compete until the end of the calendar year in which they reach age 18. A **Young Rider** is eligible from the beginning of the calendar year they reach 16 until the end of the calendar year in which they reach age 21. However, FEI Junior Tests are open only to Juniors from the beginning of the calendar year in which they reach the age of 14 until the end of the calendar year in which they reach the age of 18. Dressage riders who are between the ages of 18-21 cannot compete in Adult Amateur classes in Dressage competitions, even if they are in possession of a USEF Adult Amateur membership card.

For USDF non-member (NM) owner/lessee and USDF non-member rider there will be a USDF non-member fee of \$20/competition that must be collected by the show secretary and submitted along with the USDF Report of Fees document. In addition, a \$5 affidavit fee must be collected if the person cannot provide a copy of their USDF NM card. (For persons applying for the first time for a non-member number the \$5. affidavit fee is not required.) Owners/lessees or riders exempt from the non-member number requirements are also exempt from paying the USDF non-member fee.

Exceptions: Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number requirements and fees. There classes include Individual Breed Classes (IBC) at DSHB competitions; breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), USDF IntroductoryLevel, Pas de Deux, , Opportunity

Amateur (A) classes are open to riders, from the beginning of the calendar year they reach age 22, who hold an USEF amateur card.

All entries must be signed on all applicable lines. The adult who assumes responsibility for the horse at the show signs as "Trainer." Juniors **MUST** have their parent or legal guardian sign for them, as well as signing their own signature. Juniors and Young Riders also need to fill in their birth date to qualify for (Y) classes.

No horse may compete in more than two successive levels at any one recognized show (i.e. Training and First are permissible, Training and Second are not). Only one rider per horse in any one class. Lateness will result in elimination.

USEF requires all adult competitors to submit proof of USEF membership or pay the \$30 non-member fee. Junior non-members pay a \$30 non-member fee. All USEF members (including riders, handlers, trainers, owners, agents, coaches or lessees) are required to present either their actual membership card or a facsimile to show the show secretary prior to competing. Each competitor is responsible for supplying show management with correct association numbers (USEF, USDF) for horse, owner, rider, coach (if applicable) and trainer, before the day of the competition. The scores of the competitors who fail to supply correct numbers may not be counted toward national/local awards. **We strongly advise you to renew your USEF membership early and enclose a copy of your USEF membership card along with your entry to avoid possible penalties and confusion.**

Only a complete entry will garner the office fee refund.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Federation Entry Agreement Effective 12/1/09

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the “Federation”) and the local rules of the Competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the Competition, the Federation, their officials, directors and employees for any action *taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable-casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.*

Neither the Organizing Committee, show volunteers and staff, the facility or its owners, any host GMO, USEF or USDF or their members will be responsible for any damage, injury, or loss to persons, horses or property of exhibitors or spectators. All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

Qualifying Classes GAIG/USDF qualifying classes require both the rider and the horse be registered with the USEF and the USDF at the time the qualifying scores are earned. **COPIES OF USEF and USDF MEMBERSHIP CARDS AND USEF & USDF HORSE RECORDING CERTIFICATES MUST ACCOMPANY ENTRIES.** The fee for GAIG/USDF qualifying is \$10 extra per class. Please refer to the back of this book for more complete information on the GAIG/USDF Championships.

Freestyle entrants must submit copy of 60% +ride in the highest test of the level or tes of any higher level. Submit music to announcer at least 4 hours before the ride and arrange a sound check

Either the USDF HID# or a USDF Lifetime Horse Registration is required for all horses competing in the USEF/USDF recognized Dressage Competition or open (dressage or DSHB) class at a USEF/USDF recognized Regular or Local Competition. Horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (i.e. all Arabian or all Morgan classes) or in USDF Introductory Level tests, Pas de Deux, IPEC or quadrille classes are exempt from this requirement. Also exempt are riders in lead line, exhibitions, games and races, classes for 4-H members, and walk-trot and academy classes. Any horse participating in a GAIG/USDF Breeders' Championship Series Final, GAIG/USDF Regional Championship qualifying or championship class, or the USDF Horse of the Year award program must be lifetime registered with the USDF. All riders, handlers and owners must have USDF membership or nonmember ID number. All horses must be USEF Recorded, USDF Lifetime Registered or have Horse Identification Numbers for both USEF and USDF (except IBC).

Riders USDF membership may be either Participating or Group. Owner's USDF membership may be Participating, Group or Business: if Rider/Owner's USDF # is a Non-Member ID# then the USDF non-member fee must be paid. If the Non-Member ID card is not available then an Affidavit fee must be paid.

Pursuant to USEF rule 1211.5 each barn has one sharps container per 50 horses. Competition management may fine any individuals including trainers, owners, exhibitors, or their agent up to \$100 for improper disposal of needles or other sharps disposable instruments.

All Junior riders (18 and under) who qualify for the GAIG/USDF Regional Championships at any level are automatically qualified to compete in the 2009 U.S. Equestrian Dressage Seat Medal Semi-Finals to be held at each of the nine GAIG/USDF Regional Championships in 2009. One semi-final class will be offered for Juniors age 13 and under, and a second semi-final class will be offered for Juniors age 14-18. Contact the U.S. Equestrian Dressage Dept. for more information @ (859) 258-2472.

USDF / Dover Adult Amateur Medal Award: Awarded to the Adult Amateur with the highest score, 60% or better, in a Second Level Test 3 USDF/Dover Adult Amateur Medal Class. To be eligible, a rider must be a USEF adult amateur and a USDF Group Member, Participating Member or Intercollegiate/Interscholastic Member. No additional memberships are required. Each winner will receive a custom pewter medal.

Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/ or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of the competition.

Minors who do not have a valid drivers license which allows them to operate a motor vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the show grounds of recognized competitions.

Children who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid drivers license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s), and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardians .and/ or trainer(s) from the show grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Rule VI. Wheelchair is exempt from the definition of a motorized vehicle for purposes of this rule.

Under NC, SC, GA, and TN law, an equine activity sponsor, or equine professional is not liable for an injury to or the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities. (See N.C. Gen. Stat § 99E-1-3, S.C. Code Ann.§ 47-9-710-730, TN Code Ann.§ 44-20-101-105 and GA Chapter 12 title 4 of the Official Code of Georgia annotated.

ENTRY DOCUMENTATION REQUIREMENTS

All entries must have 3 signatures - Rider, Owner and Trainer.

Legal Guardian must sign for riders under 18 yrs. Trainer blank must be signed by person over 18 who assumes responsibility for horse. (Parents who sign as trainer are exempt from membership requirements). See **www.usdf.org** and **www.equestrian.org** and/or USEF Rule Book for further details on entry requirements. Questions? - **Save Trees, Time and Postage!**
 1. Use the back side of your Coggins copies to copy all your Current USEF, USDF, GMO membership cards and Horse Registrations (you can reduce the size) to send in with your entries. All you information will be at hand when you want to get that entry done!
 2. Be sure to WAIVE all SIGNATURE REQUIREMENTS for express mail to the Secretary. They will greatly slow receipt of your entry.

USDF Membership Benefits: USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Directory* or the USDF Web site at www.usdf.org.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership, Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF NM fee. (Note: USDF business members can own horses but cannot compete as riders with their USDF Business Membership (BM).)

Horses competing at USEF-licensed/USDF-recognized shows must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, Pas de Deux, Quadrille, or FEI ParaEquestrian classes, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot and academy classes. For foreign-owned horses competing in a CDI, USDF accepts copies of the horse identification pages from an FEI passport in lieu of a USDF HID or Lifetime Horse Registration (LHR) number.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$62), 5-years (\$250), or life (\$1,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$35). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan[®]/USDF Year-End Awards, Great American Insurance Group/USDF Breeders' Championship Series Finals, and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$175) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$20 and a USDF NM form per competition that must be collected by the show secretary and submitted to USDF along with the USDF Report of Fees document and the \$5 affidavit fee if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF member there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF Web site.

Horse Identification (HID) Number: A one-time tracking number for horses (\$20). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan[®]/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes or Great American Insurance Group/USDF Breeders' Championship Series Finals. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$65. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$85) is eligible for Adequan[®]/USDF Year-End Awards, and eligible to compete at Great American Insurance Group/USDF Breeders' Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Non-Member (NM) identification number, Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF Web site: www.usdf.org. You can submit the application online, print, fax or mail it.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date received by the competition secretary, provided the application is signed and dated by the competition secretary on that same day.

2010 USDF/Dover Saddlery Adult Amateur Medal Program

The USDF/Dover Saddlery Adult Amateur Medal Program is designed to specifically recognize and encourage adult amateurs riding at Second Level.

Awards

1. USDF/Dover Saddlery Medal Recipient

The eligible rider with the highest score of 60 percent or better in the designated Second Level Test Three class or applicable test of choice USDF/Dover Saddlery Adult Amateur Medal class at a participating competition will receive a handcrafted USDF/Dover Saddlery pewter medal and neck ribbon. Winners will receive a \$20 Dover Saddlery gift certificate for the first three USDF/Dover Saddlery Medals they win during the competition season.

2. USDF/Dover Saddlery National Merit Award

A USDF/Dover Saddlery National Merit Award will be awarded to riders winning three USDF/Dover Saddlery Medals in the same competition year.

3. Year-End Awards

The USDF/Dover Saddlery Medal National Champion and Reserve Champion are determined from the average of the top three winning ride scores during the competition year. The champion receives a \$1000 Dover Saddlery gift certificate and the reserve champion receives a \$500 Dover Saddlery gift certificate.

Rider Eligibility

To be eligible, a rider must meet the following criteria:

1. Rider must be a current USDF participating or group member at the time of the competition.
2. Rider must be an adult amateur in accordance with Article GR1306 of the USEF rules and be designated with USEF as an adult amateur as of the competition date.

IMPORTANT INFORMATION REGARDING NEW USEF DRESSAGE “OPPORTUNITY” CLASSES

“Opportunity” classes can be offered according to the level of the competition being held: only level 1, 2, or 3 competitions may do so (information on levels may be obtained on the Dressage Levels chart on the USEF website).

1. When do the new rules take effect for Dressage “Opportunity” classes?

December 1, 2009, which is the official start of the 2010 USEF competition year. This date coincides with the effective date of the new “levels” required for Dressage Competitions.

2. What rules apply for these classes?

Since the classes may only be offered at Licensed Dressage Competitions and Regular/Local Competitions with Open Dressage Divisions, all USEF Dressage Division (DR) rules apply, including dress and saddler requirements, in addition to all applicable General Rules.

3. Can a horse/rider entry cross-enter into other dressage classes?

Yes. Your prize list must state if “opportunity” riders/horse will be allowed to cross-enter into other recognized classes at your show. Please note, however, if a horse or rider enters other non-opportunity classes at your competition in which membership by participants is required, all USEF and USDF membership requirements apply for horse, rider, owner, trainer, etc.

4. What memberships are required for these classes?

Horses and riders competing in “Opportunity” classes are exempt from USEF and USDF membership requirements, and do not have to pay non-member or HID fees.

5. What about the USEF Drugs and Medications fee?

Horses entered only in “opportunity” classes are exempt from the Federation fee, including the Drugs and Medications fee. However, horses entered in these classes are still subject to and must comply with all D&M rules and are subject to testing at your competition.

6. Can “opportunity” class results count toward USEF and USDF awards?

No. Scores earned in dressage “opportunity” classes may not be used towards USEF or USDF awards or program.
